It produces a Retailer Report Card that evaluates some of the biggest U.S. retailers on their chemical management policies and actions toward safer solutions. Mind the Store is driving a competitive race to the top and transforming the marketplace toward safer products.

The Toxic-Free Legacy program works to secure precedent-setting policies in Washington State to phase out toxic chemicals used in products and advance safer solutions.
